****Discretionary vs. Non-Discretionary Arrest**

If officers were called to a crime where a victim wanted to pursue charges; there was a policy or statutorily required action; court order or warrant; the arrest is NON-DISCRETIONARY. If the action was officer-initiated and did not meet the above-noted requirements, it is generally determined to be a DISCRETIONARY enforcement action.
